### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist.

<b>Methods and materials for containment and cleaning up</b>	This product is miscible in water.  Large spills: Place the material in containers using a broom or shovel. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with

water.

Small spills: Sweep up and put into containers. Clean surface thoroughly to remove residual contamination.

Never return spills to original container for re-use. For waste disposal, see section 13 of the SDS.

## 7. Handling and storage
